Sub: Payment of advance fellowship to the external funded Integrated Ph.D./Ph.D. students.

Ref: Senate 55 (Agenda Item No. 55.6) dated November 06, 2019.

The Senate vide minutes of the 2019-1/53rd meeting held on May 24, 2019 advised Heads of all Academic Departments to encourage and help Institute funded Integrated Ph.D./Ph.D. students to qualify for external funding.

Further, the Senate in its 2019-3/55th meeting approved payment of advance to the externally funded Ph.D. students up to 50% of their fellowship amount, after 3 months in case the fellowship is awaited to be started by the funding agency after all the joining papers submitted by the research fellows are forwarded to the funding agency by the Office of Academic Affairs. The advance paid must be returned by the fellow as soon as the same is received by the student. The advance would be paid for a maximum period of six months.

Further, if the student fails to return the entire advance amount within a year from the date of start of advance payment, a late payment charge of 5% would be levied on the entire advance amount.

The advance would be paid to the fellow after submission of duly completed mandate form for advance to the Office of Academic Affairs.
